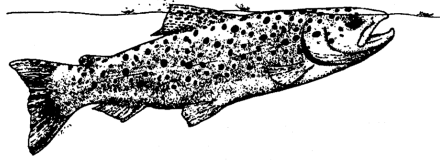

### Membership Benefits:

- Discounted rates for up to six nights per year.

### Eligibility:

This offer is exclusively for people who are new to Skitchine and for past guests of the Lodge. It is not available to existing or former partners. Our goal is to provide an affordable introduction to Skitchine Lodge, to encourage fishers to experience the beauty, tranquility, fine dining, excellent accommodations, and outstanding fishing for wild rainbow trout that defines Skitchine Lodge. Membership also provides an affordable path to partnership should you wish to become a full partner in the future.

### Membership Costs:

Pricing is simple. SAC members pay \$500 per year for membership. In return you get a \$200 discount from the public rate (currently \$397 per night) on your first three nights' accommodations. So your first three nights are \$197 per night. You have the option of booking three additional nights at a 40% discount to the public rate, thus \$238 per night. Rates include accommodations, all meals, beer & wine, and use of boats on any of our 16 lakes. And of course, kids 12 and under are half price.

As well, after six years of membership, we will waive the initial partnership fee (up to a maximum of \$2500) should you choose to become a Skitchine Partner.

# SKITCHINE ADVENTURE CLUB

## MEMBERSHIP AGREEMENT

Skitchine Lodge Limited Partnership hereby offers to the undersigned Member and the Member accepts membership in the Skitchine Adventure Club on the following terms and conditions:

1. The annual membership fee shall be \$500 with the initial payment due on the signing of this agreement and further payments of \$500 made on or before the 1<sup>st</sup> day of December in each subsequent year;
2. The term of this agreement shall be three years and will renew automatically each year thereafter upon payment by the member of the \$500 annual membership fee;
3. As a Member of the Skitchine Adventure Club you will be entitled to the following benefits:
  - (a) As of January 1<sup>st</sup> each year you shall be able to reserve on a guaranteed basis up to three nights accommodation at Skitchine Lodge at the current rack rate less \$200 per night;
  - (b) You shall have an option to reserve an additional three nights accommodation at the normal rack rate less forty (40%) per cent;
  - (c) If after six years of continuous membership in the Skitchine Adventure Club you wish to purchase an ownership interest in Skitchine Lodge Limited Partnership and provided units are available for purchase, then the initial fee to acquire the ownership interest will be waived up to a maximum of \$2,500; and
  - (d) The Skitchine Lodge Limited Partnership will not allow the number of members in the Skitchine Adventure Club to exceed thirty persons without first receiving the consent to do so by a majority of the Skitchine Adventure Club members.
4. This membership agreement is not assignable without the consent of the Skitchine Lodge Limited Partnership and such consent may be arbitrarily withheld.
5. After the initial term of three years the Skitchine Lodge Limited Partnership may terminate this agreement on one year's notice to the member.
